

Mallard Limit Hunting Rules

By signing below, the undersigned acknowledges and agrees to abide by the following rules as a condition to being allowed to hunt with Mallard Limit upon the property of Tom Green III:

1. Firearms are to be loaded in the blind ONLY. Firearms must be unloaded at all other times with the breach being placed in the open position.
2. Firearms are to be unloaded as soon as a hunter has reached his/her individual limit.
3. While not being fired the safety on the firearm must remain in the "on" position. Firearms must have a working safety.
4. Each hunter is limited to 25 shells. No more than 25 shells may be fired by any hunter regardless of whether or not a limit has been reached.
5. A wounded or crippled bird shall be counted towards a hunters total bird count. You will be charged for each bird wounded or crippled in addition to those killed.
6. No hunter shall use or be under the influence of alcohol or drugs, including prescription drugs, while engaged in hunting or other hunting activities.
7. Only an employee, agent or other person authorized by Mallard Limit shall operate farm machinery, atvs, trucks, tractors, or other motorized vehicles upon the premises before, during, or after hunts.
8. All crippled, wounded and dead birds must be collected prior to leaving the hunting area. All hunters must use reasonable efforts to ensure all downed birds are collected.
9. No low shots, shots over dogs or shots over other hunters are allowed.
10. No extreme high shots aka "sky busting" is allowed. Only shots that can result in a clean kill are allowed
11. Use of lead shot is prohibited. Hunters may use steel, bismuth, tungsten, or hevi-shot.
12. Only mallards may be shot at during hunts. Shooting at any other species of birds or other wildlife is prohibited.
13. No more than 5 hunters are allowed in a blind.

The undersigned hereby agrees that he/she has read and fully understands the rules set forth herein. The undersigned further acknowledges and agrees that these rules are incorporated herein by reference into the RELEASE OF LIABILITY, WAIVER OF CLAIMS, and EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT FOR MALLARD LIMIT. The undersigned further agrees and acknowledges that failure to abide by these rules shall result in hunting privileges being immediately suspended. Mallard Limit reserves the right to remove any hunter from the premises for failure to abide by these rules and further reserves the right to deny access to the facilities to any person who has failed to abide by these rules in the past.

I HAVE READ THESE RULES AND I FULLY UNDERSTAND ITS TERMS. I FURTHER UNDERSTAND AND ACKNOWLEDGE THAT I HAVE WAIVED LEGAL RIGHTS BY SIGNING IT AND THAT I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
